



## CONTRACTOR LICENSE REQUIREMENTS AND FEE SCHEDULE

A portion of the Municipal Code has been added for reference.

**Sec 6-3-20. -Proof of competency.**

***In order to obtain a contractor business license, an applicant shall prove competency in the specific areas as defined in Section Division 2 of this Article. Such proof of competency shall be determined by means of a written test approved by the Chief Building Official and issued by a recognized model code agency or reciprocal license agreement as determined by the Chief Building Official.***

Trade Contractor:</b> entitle the Licensee to contract for and to do the work of a particular trade or job connected with the building industry, e.g., <b>carpenter, framing and roofing.</b></p>	<p><b>1. <p><b>VII. Electrical:</b> entitles the Licensee to perform any functions as permitted under the licensure of the Colorado Electrical Board, and such licensee shall be licensed by the Colorado Electrical Board; electrical contractors are required to register with the City on the Electrical Registration Form and are not subject to any fees for such registration.</p>	<ul style="list-style-type: none"> <li>• Non-expired master's and state contractor licenses</li> </ul>	<p>\$0.00</p>

### LICENSE CLASSES WHICH DO NOT REQUIRE PROOF OF TESTING

<p><b>VIII. Asphalt Paving:</b> entitles the licensee to contract for and perform work as an asphalt paving contractor in the public right-of-way and on private property within the City, and is required in order to perform asphalt placement, patching, sealing and other similar asphalt related work.</p>	<p>\$105.00</p>
<p><b>IX. Concrete &amp; Form:</b> entitles the Licensee to contract for and install forms for concrete products, pour and finish concrete products and mix concrete products. All concrete and form work on types I, II, III, IV and V structures, as defined in the applicable Building Code, over 1,000 sq. ft. shall be under the supervision of a holder of a Centennial issued Contractor's Class A, B or C License.</p>	<p>\$80.00</p>
<p><b>X. Demolition:</b> entitles the Licensee to contract and engage in the demolition and wrecking of existing structures.</p>	<p>\$80.00</p>
<p><b>XI. Trade Contractor:</b> entitle the Licensee to contract for and to do the work of a particular trade or job connected with the building industry, e.g., drywall, insulation, painting, siding, windows, doors, flooring, cabinets, counter tops, fencing, structural steel, welding, fire protection, access control, security systems, landscaping, lawn sprinkler systems, retaining walls, signs, swimming pools, elevators and escalators, caulking, waterproofing, etc.</p>	<p>\$80.00</p>
<p><b>XII. Excavating:</b> entitles the Licensee to contract for and to do the work of cutting into public rights-of-way and excavating into the public right-of-way and on private property within the City; holders of other Centennial contractor licenses are not required to obtain an Excavating License.</p>	<p>\$80.00</p>
<p><b>XIII. Utility Contractor:</b> entitles the Licensee to contract for and perform work as a utility contractor in the public right-of-way and on private property within the City; utilities shall include, but are not limited to sewer, water, cable, gas, electricity, communications, fiber optics, and phone.</p>	<p>\$80.00</p>
<p><b>XIV. Low Voltage Contractor:</b> entitles the Licensee to contract for and install low voltage systems 50 volts or less for data, communications circuits, alarm, access control, building control systems.</p>	<p>\$80.00</p>
